Dear Paulo and Alexandra,

This communication follows my visit to Labofex on August 25-27, 2000, in which I witnessed and began to understand some rather astounding experiments and theories. That was a transformative experience and I shall always remember it with greatest fondness. I prepared a letter with preliminary proposals on August 28th, when I was there but *before* I had been shown the remarkable motor demonstrations, etc. Also, I have had time to reconsider matters and extend my suggestions. As I told you, this will be but the first of what I hope will be a continuing stream of communication from me on your efforts. Whether you expected this or not, from now on I remain your *de facto* advisor!

First, let me describe the contents of this Fedex package of "goodies":

• Two copies of our 70-minute video documentary production, *Cold Fusion: Fire from Water*, which Steve O'Donnell funded for us at approximately US \$300,000. It is selling well and has been broadcast on several PBS stations in the US and some cable outlets— not on TLC or The Discovery Channel yet, but we do not rule out the possibility of them relenting at some point. This is just a preliminary indication of our writing, organizing, and production skills in video documentary for popular consumption, working with Chris Toussaint and others. I would hope to help you with your video production some day! Please pass the extra tape to a colleague. If you need some reasonable number of additional copies for your advisors, etc., please just ask us.

- A copy of Fire from Ice: Searching for the Truth Behind the Cold Fusion Furor, my 1991 book, originally with John Wiley and Sons -9,000 copies printed and sold and one of two books that year nominated for the Pulitzer Prize by them. But now we own the full rights to this book which we reprint periodically (at a local facility) in this softbound edition in lots of 100 copies. We learned a lot about small lot publishing, ISBN's, cover redesign etc. in producing this edition of my book—note the ad material for updated items at the end of the book. This helps sales of our tapes and other books. I inscribed it to you and Alexandra. (By the way, our daughter Kimberlyn Beth Mallove —age 26, now last name Woodard—was to have been named Alexandra, but family "political considerations" and diplomacy intervened!)
- A copy of *Nuclear Transmutation: The Reality of Cold Fusion*, by Dr. T. Mizuno. This book was translated from the Japanese by our Jed Rothwell and the publishing project was managed and executed by our Barbara DelloRusso and Christy Frazier. We printed 5,000 copies. This was our first experience with book publishing, and I think it came out quite well. We added value to its original Japanese content by including the Mizuno technical papers at the end, plus added a glossary and historical time line. Perhaps we c could help with your book publishing efforts some day, under *Infinite Energy* imprint, if necessary.
- Excess Heat: Why Cold Fusion Research Prevailed by Charles Beaudette (MIT EE 1952). Infinite Energy Press is the exclusive distributors of this book. We are marketing and distributing the book on our own www site as well as on Amazon and Barnes and Nobles sites. We played a major role in editing and fashioning the book from its first arrival at our doorstep. Our Christy Frazier has become a skilled and energetic expert in book marketing and distribution.
- My C.V. and somewhat out-of-date list of references —no articles by me in Infinite Energy or defunct "Cold Fusion" Magazine are cited, plus I have submitted other papers that are not mentioned. Just to give you a more complete picture of me. Actually, it is impossible to give a *complete* picture of me since I am of *infinite* energy, literally and figuratively!
- Biological Transmutation, by Prof. C. Louis Kervran, just to get your mental wheels spinning on this topic of increasing interest (there is as of May, 2000, an international society to deal with this topic!). We have published several articles in *Infinite Energy* on biological transmutation. I'd be curious about your reaction to this book, which we will begin to sell as part of our catalog. It might well fit in somewhere in the vast edifice of your theories and experiments.
- A copy of the BBC (1994) TV series on "Heretics," which includes Benveniste, Robert Jahn at Princeton, Eric Laithwaite, and others.
- A copy of a tape of Josef Papp in his laboratory, showing the engine and its testing. It is about 23 minutes long. We have other videos and material about

Papp, which we can share with you later. (This video enclosed does NOT come from Sabori, although we have one of his tapes too -- about like yours but less detailed and it did mention Papp by name!)

• I intended to include in this package, but it was missing at the last minute! — the article in *Wired* magazine (latest issue, reddish cover) about our acquaintance, Dean Kamen of Manchester, New Hampshire —in the event that you forgot to obtain the copy. Please *do* get a copy!

Since leaving your lab last Monday, I have been consumed with regret that I had not had a chance to study your series of 20 articles at greater length. Perhaps I would have stayed up all night reading them had I seen the motor demo first!! I hope, prior to the publication of these magnificent works, I will have the opportunity to review them more closely.

By two days after I had returned from Labofex, I had briefed the following individuals about what I had seen and heard, per the agreed guidelines of my letter of August 28th: Dr. Dan Cavicchio, Charles Entenmann, John Thompson, and Steven O'Donnell. All were brimming with enthusiasm and wonder, which of course did not surprise me. They all stated that they are ready to receive from you a one day series of demonstrations and discussions of science, business plans, and investment prospects. They will all come in one group. My belief is that this group of individuals and I hold one major key to acquiring a significant portion of your requested funding. I cannot possibly imagine that they would not be interested in pursuing investment at significant levels. Whether all terms would be initially agreeable is to be seen. I, of course, will push VERY HARD to have at least Entenmann write you out a VERY BIG CHECK, which I am absolutely sure he is *able* do.

On the matter of consulting briefly on one tiny part of the Advanced Thermodynamics project at NERL that I described to you only in the most brief terms: we have acquired a consultant who is qualified to help us with an independent evaluation. Thank you for at least considering our offer, but we understand the concern about possible conflict of interest. If we need further help on a narrow technical problem, as you described, I might call on you again. Of course, if our program shows promise of substantially more experimental and theoretical success by the end of October as we anticipate, we expect that our supporters will be helping us with funding at a moderate level — several hundred thousand dollars— to get to the next stage. There could conceivably be some advantage of our potential technology to your work, down the road.

Since leaving Labofex I have reflected on many of your concerns. I fully understand them, now that I have had a chance to reflect more deeply on the implications:

- Yes, off shore development has significant advantages in tax and security matters. But please consider finding some sub-optimal but acceptable North American location as an alternative. Also, even with the off-shore plan, please do consider that a publishing effort and demonstration/education/publicity component could exist in North America, especially right here in Bow, New Hampshire, with NERL/Infinite Energy Press in the lead. We stand ready to help you. Perhaps that prospect would sweeten Entenmann-O'Donnell's confidence if they knew we here would play some significant role.
- Your Aurora Publications project— the proposal in ABRI of a trimonthly journal/webzine plus research monographs would be an activity that we would relish to assist or in large measure carry out. I believe that with additional funding we would have the infrastructure to expand our capabilities to any level that you required. We also have connections with other publishers, who could provide even more advice and infrastructure to you. *Please* consider us highly for this role. I can think of nothing better we could do with the experience that we have built up.
- I know we discussed last night the threshold funding question. Surely there must be some multi-million dollar number that would suffice to fund the initial move off-shore by your group for several years, even in a less-than complete manner! Then, with the success of www education and perhaps demonstration devices, the remainder of the funding could be achieved. Think of it as a two stage rocket with the partially built second stage nearly certainly to be built if the first stage has achieved its demonstration device goals.

After leaving Labofex I realized I had not gone down my complete list of anomalies in physics to ask you about — especially "cold fusion" and heavy element transmutation. Surely you must have thought about the possible mechanisms by which "Aetherometric Science" could assist in explanations. Let us discuss these matters in the future. In a similar vein, I have this thought: We here at CFTI, because of our large "fishnet" that brings in both invalid and valid claims to our attention, could serve as an early warning, early detection system for your developments and science—much as it does for us already. It would give you new sources of phenomena to explain and integrate into your large cosmology, making it all the more strong. Please reflect on this. We have much more information in our files than we can print in *Infinite Energy*, and this gathering of both the bitter and sweet continues to grow.

It is toward the end of the day, at the end of an exhausting week that followed my visit. I had intended to write more and be more philosophical about some matters such as ethics, goals, purpose, meaning, life, death, etc. The extended writing on these reflections can wait for my internal energy stores to be recharged next week. This weekend Joanne and I will be spending our time in northern New Hampshire to celebrate the Labor Day weekend and our impending 30th Wedding Anniversary (September 6th). I will be sending this

via Fedex and hope that it reaches you in time for some of your meetings next week. I hope that Uri went through his surgery in good form and that I will be hearing from him before much longer.
